The type of personal information we collect

We currently collect and process the following information:

- Personal identifiers, contacts and characteristics (for example, name and contact details)
- User Email Address
- User Forename and Surname
- Company Address
- Company Email Address
- Company Website
- Company Phone Number

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- We collect personal data if you voluntarily provide it when contacting us (e.g. via contact form or e-mail).
- The specific data that is collected is listed on the respective contact forms. We use the data provided by you to process your enquiries.
- The legal basis for the data processing is Art. 6 (1) (b) GDPR, insofar as your message is related to an existing or upcoming contract with you. If this is not the case, the legal basis is Art. 6 (1) (f) GDPR, as the processing is necessary to fulfil our legitimate interest in the proper processing of contact requests. In order to be able to properly allocate enquiries, the provision of personal data is necessary.

We use the information that you have given us in order to

- Set up user accounts
- Process orders
- Process user enquires

Use of payment service providers

For the processing of payments, we use the following service providers who act as separate data controllers:

Card payments are processed by Stripe Payments Europe, Ltd, One Building, 1 Grand Canal Street Lower, Dublin 2, Ireland. This may also involve the transfer of personal

How we store your personal information

Your information is securely stored.

We keep User Email Address and User Forename and User Surname for a period of one year after a user has closed their account. We will then dispose your information by deleting from our databases.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
